In continuation of this Institute notification of even no. dated 13.09.2017 this is for information of all concerned that a written competitive examination through online mode for the post of Assistant (G/F&A/S&P) Gr. III under the Post Codes: 150201 in response to the Advertisement No. 02/2015 of this Institute is scheduled to be held on **1st November, 2017** (Wednesday) at New Delhi at the following venue/test centre :

Outstation candidates will be reimbursed to and fro single Sleeper Class Rail fare (by Mail or Express) by the shortest route, from the place of undertaking the journey or from the present address given in the application, whichever is nearer, for attending the Test on production of proof of journey. Reimbursement of TA would be allowed only to the eligible outstation candidates appearing for the Test. Such candidates are advised to furnish their bank details i.e. A/c No., Name and address of the Bank, IFSC Code etc. at the time of Test. The TA claims, as per rule, would be transferred electronically in the concerned bank accounts subsequently. The TA Form for claiming the reimbursement is at '**Annexure – I**' of this notice. All the eligible candidates are requested to submit his/her filled up TA form along with photocopies of to and fro rail tickets.

The Call Letter and Information Handout will be made available to be downloaded by the candidates on the website of CSIR-CMERI i.e. www.cmeri.res.in shortly. Hard copy of the Call Letter will **not** be sent to the candidates by post or by any other means. Candidates without copy of Call Letter will not be permitted to appear for the online competitive examination.

The facility of Scribe, on request, may be provided to Visually Handicapped (VH) candidates and to only such Orthopedic Handicapped (OH) candidates who are afflicted by Cerebral Palsy or having locomotor disability wherein the dominant writing extremity is affected to the extent of slowing down the performance of the candidate and not to all OH candidates. The level of disability should be 40% or more.

It is observed that some of the PWD candidates have requested this Institute to provide them with the facility of a Scribe. In this regard, all such Persons with Disability (PWD)/ Physically Handicapped (PH) eligible candidates who may require the facility of scribe for the online examination as per rules are requested to immediately confirm their requirement of scribe within 15.10.2017 at email id : recruit@cmeri.res.in.
