## **Instructions/information for Short-listed Candidates:**

- 1. Candidates must bring the signed copy of the Online Application and Proof of eligibility (original certificates, marksheets, category certificate) which are mandatory for appearing in the interview.**
2. No TA/DA shall be paid to the shortlisted candidates for attending the interview and they will have to make their own arrangement for accommodation.
- 3. Please note that AcSIR does not provide with any scholarship/fellowship/stipend. Candidates who have applied with JRF/SRF/INSPIRE/any other fellowship must have a valid and tenable fellowship. Please produce documents related to fellowship at the time of Interview. Candidate with Valid Fellowship may please identify/explore about possible supervisor for carrying out doctoral research work.**
4. Candidates must confirm their attending the interview by sending a Statement of Purpose (SOP) by email **coordinator.cmeri@acsir.res.in** immediately but before two days of the interview.
5. The candidates, Scientists, JRF, SRF, Project assistance of CSIR-CMERI, if not submitted, have to submit a "Statement of purpose" along with the recommendation of the proposed guide, with whom the candidate desires to undertake the proposed thesis work. It is preferable to have Co-supervisor for all the candidates. In case, supervisor is having service less than 3 yrs, Co-supervisor's consent and recommendation is must.
6. If a candidate is short-listed inadvertently and he/she is found ineligible at the time of the Interview, he/she will not be allowed for interview.
7. If CGPA of the candidates of the reserved categories are more than or equal to the CGPA determined for unreserved category as per the short-listing criteria, they will also be considered for selection to the unreserved posts provided they fulfill other criteria specified for these unreserved posts.
8. The candidates sponsored by the Industries or other organizations must submit the sponsorship document at the time of interview, in absence of which they will not be allowed for interview.

Any applicant who fulfills the short-listing criteria mentioned above but his/her name does not appear in the list of short-listed candidates for interview may communicate to the program coordinator at the following E-mail address: **coordinator.cmeri@acsir.res.in**. Such candidates are requested to appear for the interview with valid documents on the date and time as per the Interview Schedule.
