The Medical Officers of CSIR-CMERI will issue Medicine requisition slips of admissible prescribed medicines only under their signature, duly stamped, clearly mentioning the persons's Name & valid Medical Card number. The Medical officers are also requested to check validity of Medical cards while the same are being placed before them at the time of Medical examination of the patient concerned / dependent family members.

The above listed Vendors / Retailers will supply only the admissible prescribed medicines. No substitutes, either demanded by the Employee / Pensioner / Eligible dependent family member or as decided by the authorized Medicine Vendor / Retailer will be entertained.

Dispensing of medicines by the aforesaid vendors will be operational from **01.08.2025** to **31.07.2026**. Any change, extension or otherwise, will be notified accordingly.

Medicines, as prescribed and admissible, may also be procured by the individuals concerned, from any other Medicine retail outlet(s), as per their choice, on payment basis and reimbursement will be made only in r/o GST bill/invoice of such medicine retailer after deduction of discount being offered by the current listed vendors/ retailers.
