Sub: ENGAGEMENT OF CSIR-JRF(GATE) UNDER CSIR-CMERI ADVT. NO. 03/2020

It is for information of all concerned that applications were invited by CSIR-CMERI for the position of CSIR-JRF(GATE) in response to the Institute Advertisement No. 03/2020 and Corrigendum of even no. dated 05.01.2021. As per the stipulations of the advertisement, the eligible candidates were required to submit online applications through the Institute's dedicated email id i.e. temprct@cm eri.res.in within 02.08.2020 at 23:59 Hrs.

As per the said Advertisement, the candidature of only those applicants whose soft copies of applications were received through the Institute's dedicated email id within the prescribed last date i.e. 02.08.2020 at 23:59 Hrs. were to be considered by the Institute and others to be rejected. Accordingly, the Screening Committee scrutinized the applications whose soft copies were received within stipulated date & time with respect to the educational qualification, valid GATE score, age, etc. of the candidates.

The Screening Committee has considered the candidature of the applicants on the basis of the information furnished and relevant documents attached by them in their Application Form (soft copies) received through email within stipulated time and recommended all those candidates whose applications were found in order as per the prescribed format and who fulfill the essential advertised eligibility criteria for a particular position against which one has applied and qualify in the category wise cut-off percentage of marks to determine the shortlisted candidates to be called for Interview as decided by the Screening Committee. The committee also recommended that at any stage during the screening / selection process, if it is detected that they are not eligible for the position for not possessing the required qualification, valid GATE score, over aged, their candidature may be summarily rejected without assigning any reason.

Accordingly, the candidates who fulfill the advertised essential criterion like educational qualification, age, valid GATE Score, caste certificate etc. and possessed the requisite minimum percentage of marks in their B.Tech degree as decided by the Screening Committee have been shortlisted for interview. The list of such shortlisted/recommended candidates for online Interview is given in Annexure - I. The list of the candidates who have been found ineligible during the screening process as per the advertised essential eligibility criteria, number of candidates not recommended out of eligible candidates because they did not possess the required cut-off percentage of marks fixed by Screening Committee and number of candidates who have been rejected by the screening committee due to Applications received after the last date given in Annexure - II.

The following Codes have been utilized in the Annexure-II in determining ineligibility/rejection of the candidates or the candidates not recommended for interview:-

SC-1 : Overage, hence ineligible

SC-2 : Not fulfilling advertised Essential Qualification, hence ineligible

SC-2(i) : Does not have GATE qualified/valid GATE Score

SC-2(ii) : Does not meet Essential Educational Criteria in relevant areas / disciplines

SC-2(iii) : Candidates with M.E./M.Tech degree

SC-3 : Application incomplete, hence ineligible

SC-3(i) : Unsigned Application

SC-3(ii) : Application not in prescribed format / Form

SC-3(iii) : Incomplete applications (i.e. without relevant testimonials in support of Date of Birth, Qualification, SC/ST/OBC Certificate etc.), hence ineligible

SC-4 : Application received after the stipulated time limit i.e. 02.08.2020 at 23:59 Hrs., hence ineligible.

The Interview (Selection Committee meeting) for the shortlisted candidates would be held through online mode via 'Skype' on 19th February, 2021. The Selection process/online Interview may continue till late evening/next day, candidates are advised to remain prepared accordingly and also follow some instructions for online interview notified for general information of the concerned candidates as Annexure-III. Further, all the subsequent information / notification / corrigendum regarding this selection process will be hosted on the Institute's website only. No interim inquiries will be entertained. Hence, applicants are requested to follow the Institute website i.e. www.cm eri.res.in for updates.
