**Sub : Recruitment to the post of Technical Officer (Gr.III) against this Institute Advt. No. 05/2018 -
Schedule of Document Verification - req.**

Reference of all concerned is hereby invited to this Institute notice of even number dated 12.09.2024, wherein the schedule of the document verification for the screened-in provisionally eligible candidates, to be called for Trade Test for the recruitment of Technical Officer (Gr. III) against the Institute Advt. No. 05/2018, had been notified. In accordance with this, the Document Verification process for the concerned candidates was conducted at this Institute.

Further to the above, this is for information of all concerned that in response to some of the candidates' requests about rescheduling the date for document verification due to valid reasons and the abrupt cancellation of trains and flights due to the cyclonic storm 'Dana', it has now been decided by the Competent Authority, CSIR-CMERI to provide a **second and final opportunity (10 days) during 18th to 22nd and 25th to 29th November, 2024 (from 10.30 AM to 04.00 PM)** for Document Verification to the candidates remaining absent during the earlier schedule, notified vide Instt. Notice of even no. dated 12.09.2024. Accordingly, the concerned absentee candidates may appear for their document verification process on either the aforementioned dates at this Institute i.e. CSIR-CMERI, Mahatma Gandhi Avenue, Durgapur-713209.

In this connection, it may be noted here that **no separate call letter will be issued to the candidates who are given second chance to appear for Document Verification.** The Concerned absentee candidates are advised to **bring the Original Call Letter issued in accordance with the earlier schedule** for the Document Verification alongwith all the original documents and a set of self-attested photocopy of each document mentioned in the Call Letter. Further, the concerned candidates are advised to refer to this Institute notice of even no. dated 12.09.2024 and read the instructions carefully for strict compliance for appearing in the document verification process. The concerned absentee candidates who did not receive their call letter may report to the undersigned on any day (from 10.30 AM to 04.00 PM) during the aforementioned scheduled days of verification process at the venue itself with their original certificates, Aadhaar/ Voter ID, and a passport size photograph used in the application form for issue of duplicate call letters. An E-mail will be sent to the absentee candidates on their email address provided in their Application Form.

It is reiterated that **the candidature of those candidates, whose documents are successfully verified during the verification process, will 'ONLY' be called for the Trade Test.** It is mentioned here that if the absentee candidates of earlier schedule do not appear for the document verification in the second & final spell also as detailed above, it will be presumed that they are not interested to appear for the same /further process of selection and **their candidature for the recruitment drive i.e. against the Advt. No. 05/2018, will be treated as CANCELLED and no further correspondence in this regard will be entertained by this Institute.**

Further, it may be stated that all the information relating to schedule of Trade Test, any addendum /corrigendum etc. will be made available through CSIR-CMERI website www.cmeri.res.in only. Therefore, the concerned candidates are advised to follow the Institute website accordingly.
