सूचना / NOTICE

Sub: Recruitment of Technician I (Group II) under Advertisement No. 02/2018- reg.

Reference of all concerned is hereby invited to this Institute notice of even number dated 06.12.2018 regarding recruitment of Technician I(Group II) under CSIR-CMERI Advertisement No. 02/2018. Further to the above, following are brought to the notice for information of all concerned.

As per the said notice the candidature of only those applicants whose hard copy of applications were received within the prescribed last date i.e. within 20.06.2018 were to be considered by the Institute and others to be rejected. Accordingly, the Screening Committee scrutinized the applications whose hard copies were received within stipulated time with respect to the eligibility criteria as stipulated in the advertisement No. 02/2018 of this Institute.

The following Codes have been utilized during the screening process for recommending the candidates to be **provisionally eligible / ineligible**. The reasons for such recommendation have been given in form of relevant Codes as enumerated below.

Accordingly, the list of all the candidates considered **eligible/ provisionally eligible** on the advertised essential criterion like educational qualification, relevant trade, age, etc. whose hard copy of applications submitted in the prescribed manner, complete in all respect and accompanied by required documents have been received, is given in **Annexure – I**. The list of candidates who have been found **ineligible** during the screening process as per the advertised essential eligibility criteria has been given in **Annexure – II**.

It may be noted that vide the aforesaid notice dated 06.12.2018 the name of Shri S. Santosh Naik, Appln. No.180201_1241 was shown inadvertently under Annexure – I in place of Shri Gurjinder Singh, Appln. No.180201_1243 whose hard copy of application was received within the stipulated last date. The hard copy of application of Shri S. Santosh Naik, Appln. No.180201_1241 has not been received by the Institute.

Against the Post Codes **180211, CL/180220 and CL/180221** either there were no eligible candidate or there were insufficient response / insufficient number of eligible candidates i.e. less than three candidates available for the test. Therefore, in terms of the provision of para 10.2 of the CSIR Service Rules 1994 as amended from time to time, the above Post Codes have been cancelled.

It may further be noted that in compliance of the Hon'ble Calcutta High Court Order dated 08.06.2018 in the Case No. W.P. 231(W) of 2018 (Mousam Chowdhury & Another Versus Union of India & Ors) two applications received from the petitioners namely **Shri Shyam Das Banerjee** and **Shri Mousam Chowdhury** under the Post Code 180207 were accepted by the Institute and placed before the Screening Committee for consideration and evaluation within the framework of the recruitment process and extant rules. In this regard, the recommendation of the Screening Committee as regards their eligibility are given below.


It is notified that the candidates shortlisted at this stage would be required to appear for the trade test in their respective trades, detailed scheduled of which would be notified shortly. The candidates qualifying in the trade tests under different post codes would be eligible to be called for a competitive written test, details of which would be notified later. The final merit list of the candidates would be prepared based on the performance of the candidates in the said written test.

In case a candidate is employed in Govt./PSU/Autonomous Body, he/she must intimate his employer in this regard and they must bring a clear '**No Objection Certificate**' from their employer during the written test as per Annexure - III failing which they will not be allowed for the written test.

It may be noted that the Screening process of the applicants has been carried out on the basis of the information furnished in the Application Form and the documents furnished by the candidates. At any stage during the screening / selection process or even after their joining to the post if it is detected that they are not eligible for the post(s) for not possessing the required qualification, experience, over aged or not belonging to the category to which they claim, incomplete / inappropriate application, their candidature may be summarily rejected without assigning any reason and appropriate action may be taken in this regard.

Further communication on the subject would be notified only in the Institute website. Therefore, the candidates are advised to follow the Institute website www.cmeri.res.in for update.
