Sub: Recruitment of Scientist / Sr. Scientist at CSIR-CMERI under Advertisement No. 09/2017

Reference of all concerned is hereby invited to this Institute notice of even number dated 14.03.2018 and 20.03.2018 regarding recruitment of Sr. Scientist & Scientist under CSIR-CMERI Advertisement No. 09/2017. Further to the above, following are brought to the notice for information of all concerned.

As per the said notice the candidature of only those applicants whose hard copy of applications were received within the prescribed last date i.e. within 05.02.2018 were to be considered by the Institute and others to be rejected. Accordingly, the Screening Committee scrutinized the applications whose hard copies were received within stipulated time with respect to the educational qualification, research experience, product development etc. of the candidate. It may be noted that one hard copy of application of Mr. Kanka Goswami under Post Code 170902 was received within the prescribed date. Accordingly, the number of hard copy of applications received within last date for that Post Code may be read as 179 instead of 178 as stated in notice dated 20.03.2018.

The following Codes have been utilized during the screening process for recommending the candidates to be eligible / ineligible. The reasons for such recommendation have been given in form of relevant Codes as enumerated below.

SC-1: Above prescribed Age Limit (Overage), hence ineligible.

SC-2: Does not meet Essential Educational Criteria, hence ineligible.

SC-3: Does not meet Essential post qualification experience criteria, hence ineligible.

SC-4: Incomplete applications (i.e. without photograph, application fees, applicable testimonials in support of Date of Birth, Qualification, Experience, Caste, Unsigned application etc.), hence ineligible


SC-5: Application not received through Proper Channel from the employees of Govt. Dept., hence provisionally eligible [Ref. para 5(k) of the Advt. No. 09/2017]

Accordingly, the list of the candidates who have been found ineligible during the screening process as per the advertised essential eligibility criteria have been given in Annexure – I. The list of all the candidates considered eligible on the advertised essential criterion like educational qualification, age, experience etc. whose hard copy of applications have been received is given in Annexure – II. In terms of para 4(a) of the advertisement out of these eligible candidates the candidates possessing higher educational qualification and marks, research experience, achievement in product / technology development, patent / publication etc. have been shortlisted for interview. The names of such shortlisted candidates is given in Annexure – III. In case a candidate is employed in Govt./PSU/Autonomous Body, he/she must bring a clear 'No Objection Certificate' from the employer as per Annexure - IV failing which he/she will not be allowed for interview.

It may be noted that the Screening process of the applicants has been carried out on the basis of the information furnished in the Application Form. At any stage during the screening / selection process if it is detected that they are not eligible for the post(s) for not possessing the required qualification, experience, over aged or not belonging to the category to which they claim, incomplete / inappropriate application, their candidature may be summarily rejected without assigning any reason. The candidates who have any query on the above may submit their email to recruit@cm eri.res.in within 16.11.2018 for clarification on the matter after which no such queries would be entertained by the Institute.

The venue and schedule of the Selection Committee meeting for the shortlisted candidates would be notified shortly and call letter to the shortlisted candidates would be dispatched by Speed/Registered Post accordingly. Further communication on the subject would be notified only in the Institute website. Therefore, the candidates are advised to follow the Institute website www.cm eri.res.in for update.
