## **Instructions/information for Short-listed Candidates:**

- 1. The applicants whose names do not appear in the list of the shortlisted candidates as recommended by the Screening Committee of the Institute, still feel that they are fulfilling the screening criteria (or short-listing criteria) and are eligible to be called for interview, may communicate to the AcSIR Coordinator at the following (Email: coordinator.cmeri@acsir.res.in). Such Candidates are requested to appear for the interview with valid documents.
- Candidates are advised to send their confirmation for attending the interview along with a Statement of Purpose
  (SOP) by email to AcSIR Coordinator (Email: coordinator.cmeri@acsir.res.in) at least before seven days of the
  interview i.e., 28/06/2022.
- 3. The Project Assistants/SRF/Scientists/Technical Staff, who are provisionally screened for IDDP (Engineering), have to submit a "Statement of Purpose (SoP)" along with the recommendation of the proposed guide, with whom the candidate desires to undertake the proposed thesis work. It is preferable to have a Co-supervisor for all the candidates. Supervisor should have at least 3 yrs. of service.
- 4. If percentage of marks of the candidates of the reserved categories are more than or equal to the percentage determined for unreserved category as per the short-listing criteria, they will also be considered for selection to the unreserved seats provided they fulfill other criteria specified for these unreserved seats.
- 5. The candidate must produce the final qualification marksheet during the time of the interview. If any candidate failed to produce the same, his/her candidature may stand canceled on immediate effect.
- 6. Candidates must bring the signed copy of the Online Application and Proof of eligibility (original certificates, marksheets, category certificate) which are mandatory for appearing in the interview physically (2 sets). Candidate who will appear for online interview must produce the said documents during the time of admission (2 sets) for verification.
- 7. No TA/DA shall be paid to the shortlisted candidates for attending the interview and they will have to make their own arrangement for accommodation.
- 8. Please note that AcSIR does not provide any scholarship/fellowship.
- 9. The Candidates Sponsored by Industries or other organizations must submit the sponsorship documents and "NOC" provided by their industry or organization at the time of Interview in absence of which they will not be interviewed.
- 10. The Selection interview process will be conducted through "Hybrid" mode at CSIR-CMERI Durgapur on. All shortlisted candidates have to carry a valid COVID-19 "Negative" report (48 Hrs. prior to the campus visit) or double vaccination certificate and need to produce before entry to the campus.
- 11. The list of the shortlisted candidates is provisional and mere being shortlisted for consideration to be called for interview does not confer any claim of admission in the above program. If at any subsequent stage of admission process, it is found that the candidate does not fulfill the eligibility criteria, their candidature shall be cancelled without assigning any reason whatsoever.
